

Privacy Policy

Effective October 3, 2016

The purpose of this Privacy Policy is to inform you, a user of our Internet Site at www.gogosgreekgrill.com (the "Site"), about how Go-Go's Greek Grille, LLC ("Go-Go's", "us", "our", and "we") uses information collected through our Site.

We hope to make your experience with our Site an immersive and interesting one, engaging the many versatile uses that online technology innovations offer. In the process of doing this, we may, at our sole discretion, collect and use "Personal Information" (such as, but not limited to, name, street address, telephone number or e-mail address) that is collected through this Site, subject to the terms of this "Privacy Policy."

By using this Site in any manner, you expressly agree that you shall be bound by the **Terms and Conditions** of this Site and the Privacy Policy. If you do not agree with every provision, do not sign use this Site.

The protection of your identifying information that you entrust with us is a core responsibility and value of Go-Go's Greek Grille, LLC. As part of this commitment, Go-Go's Greek Grille, LLC adheres to and abides by the Safe Harbor Principles promulgated by the United States Department of Commerce regarding the transfer of personal data to the United States from the European Union or Switzerland.

We may from time to time collect basic information about your computer, browser and connection to the Internet to ensure that we can deliver the forward-thinking, professionally friendly service for which we have become known.

1. User Information

We may, at our election, store information that we may collect through cookies and log files to create a profile of our users. Should we do so, we will not link this information we store in cookies to any personally identifiable information you submit while on our Site. We also may use "cookies," which are essentially small pieces of data stored on a user's computer tied to information about the user. There may be both session cookies and persistent cookies. For the session cookie, once users close the browser, the cookie simply terminates. A persistent cookie is a small text file stored on the user's hard drive for an extended period of time. Persistent cookies enable us to track and target the interests of our users to enhance their experience on our Site. By setting a cookie on our Site, users would not have to log in a password more than once, thereby saving time while on our Site. If users reject the cookie, they may still browse our Site, however they will not be able to buy gift cards or use other interactive functionality that requires cookies. Persistent cookies can be removed by following Internet browser help file directions. We may also use log files. Like a majority of Website servers, we use log files for error diagnostics, session management, and determining our advertising efficiency. This includes internet protocol (IP) addresses, browser type, internet service provider (ISP), referring pages, platform type, date/time stamp. IP addresses, etc. are linked to personally identifiable information.

2. Communications from the Site

If you buy something on our Site, you may receive a number of emails throughout the transaction process and they may sometimes receive phone calls from our Customer Service department to ensure smooth

transactions. We may also occasionally send out service-related announcements, for instance, if our service is temporarily suspended for maintenance. Generally, these communications are not promotional in nature, and users will receive them as long as their accounts are open. Out of respect for the privacy of our users we present the option to not receive these types of communications, as explained in the Choice and opt-out section below.

3. Sharing Information

At Go-Go's, we care about your privacy. We will not share your credit card number or any other financial information with any third party except for the verification purposes mentioned above. We may share your personal information with third parties in the following instances:

Within Our Corporate Family:

We may share information with our parent company, subsidiaries, joint ventures or other companies under common control, where it may be used to provide joint services or for purposes such as internal statistics, strategic decision-making, customer verification, fraud prevention and security.

Legal Disclaimer:

Though we make every effort to preserve user privacy, we may disclose personal information when required by law or under the good-faith belief that such action is necessary under applicable law. We may disclose personal information in order to establish or exercise our legal rights or defend against legal claims. We also share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, to protect our property or interests or that of our agents and employees, and to protect personal safety or the public.

Aggregate Information (non-personally identifiable):

We share some aggregated demographic information (age, zip codes) with some of our partners. This is not linked to any personally identifiable information. We may use third-party advertising companies to serve ads on our behalf. These companies may employ cookies and action tags (also known as single pixel gifs or web beacons) to measure advertising effectiveness. Any information that these third parties collect via cookies and action tags is completely anonymous.

Third Party Service Providers:

We may disclose information about individual users to third parties who provide services to Go-Go's Greek Grille, LLC. These third parties provide a variety of services to Go-Go's Greek Grille, LLC, including, without limitation, verifying credit card information, tracking Internet marketing campaigns, and processing credit card transactions. In addition, these services may include enhancing the information Go-Go's Greek Grille, LLC collects about its customers. We may also use third-party email providers to assist with sending our marketing emails. These companies do not retain, share, store or use personally identifiable information for any secondary purposes. Any personally identifiable information that Go-Go's shares with its service providers may only be used to provide services to Go-Go's and the service providers will not be given permission to use such information for other purposes.

Business Transitions:

In the event Go-Go's goes through a business transition, such as a merger, an acquisition by another company, or a sale of all or a portion of its assets, users' personal information will, in most instances, be part of the assets transferred. Users will be notified via prominent notice on our Site should a change of ownership happen which would change the way personal information is used. If, as a result of the business transition, the users' personally identifiable information will be used in a manner different from that stated at the time of collection, users will be given the option to continue sharing their information consistent with our notification of changes section. However, nothing in this Privacy Policy is intended to interfere with the ability of Go-Go's to transfer all or part of its business and/or assets (including the Site), for any purposes, without any limitation whatsoever. Go-Go's specifically reserves the right to transfer or share a copy of personally identifiable information collected from its Site to the buyer of that portion of its business relating to that information.

4. Security

This Site takes every reasonable precaution to protect our users' information. When users submit sensitive information via the Site, their information is protected both online and off-line.

When our registration/order form asks users to enter sensitive information (such as credit card number), that information is encrypted and is protected with encryption software, currently SSL encryption. While on a secure page, such as our order form, the lock icon on the bottom of web browsers such as Mozilla Firefox, Google Chrome, or Microsoft Internet Explorer becomes locked, as opposed to un-locked, or open, when users are just 'surfing'. While we use SSL encryption to protect sensitive information online, we also protect user-information off-line. Access to all users' information, not just the sensitive information mentioned above, is restricted to our offices. Only employees who need the information to perform a specific job (for example, our billing clerk or a customer service representative) are granted access to personally identifiable information. Employees are kept up-to-date on our security and privacy practices. The servers that store personally identifiable information are in a secure environment, behind a locked cage at a professional hosting company. Although we endeavor to create secure and reliable sites and to safeguard against unauthorized disclosures of information, we cannot assure you that personally identifiable information that we collect will never be disclosed in a manner that is inconsistent with this Privacy Policy. You hereby acknowledge that Go-Go's is not responsible for any intercepted information sent via the Internet, and you hereby release us from any and all claims arising out of or related to the use of intercepted information in any unauthorized manner.

5. External Links

The Site contains links to other websites maintained by third parties. Please be aware that Go-Go's exercises no control over linked sites and is not responsible for the privacy practices or the content of such sites. Each linked site maintains its own independent privacy and data collection policies and procedures, and you are encouraged to view the privacy policies of these other sites before providing any personal information.
